

# Modern slavery and human trafficking statement

#### Introduction

This statement sets out ASMPT SMT UK Ltd ASMPT UK Holding Ltd (Hereon referred to as ASMPT UK) actions to understand all potential modern slavery risks related to its business and to put in place steps that are aimed at ensuring that there is no slavery or human trafficking in its own business and its supply chains. This statement relates to actions and activities during the financial year 1<sup>st</sup> January 2024 to 31<sup>st</sup> December 2024.

As part of an Engineering and Electronic Manufacturing supply chain, ASMPT UK recognises that it has a responsibility to take a robust approach to slavery and human trafficking.

ASMPT UK is absolutely committed to preventing slavery and human trafficking in its corporate activities, and to ensuring that its supply chains are free from slavery and human trafficking.

# Organisational structure and supply chains

ASMPT UK designs, develops, and produces Printing Equipment and parts primarily for the SMT and Semiconductor industries.

### **Countries of operation and supply**

ASMPT UK currently sources materials and sells finished products globally. A list of countries where these activities take place is available on request.

The following is the process by which the company assesses whether activities or countries are high risk in relation to slavery or human trafficking:

- ASMPT UK work closely with our global suppliers to ensure to the best of our ability that all items are sourced compliantly, ethically and in accordance with all human rights legislation.
- ASMPT UK stipulate in all Supply Contracts that products must be supplied in accordance with RoHS, REACH and EICC regulations.
- EICC is the Electronic Industry Citizenship Coalition® (EICC®) who's International Code of Conduct establishes standards to ensure that working conditions in the electronics industry supply chain are safe, that workers are treated with respect and dignity, and that business operations are environmentally responsible and conducted ethically.



# **High-risk activities**

The following activities are at high risk of slavery or human trafficking:

- Mining of precious metals used within electronic manufacturing such as yttrium, lanthanum, terbium, neodymium, gadolinium, and praseodymium.
- Products sourced from countries whose Human Rights record is considered below acceptable levels
- Workers in traditionally low paid countries being exploited by employers

ASMPT UK has a moral responsibility of ensuring that no slavery has been used in producing the products we sell. This not only applies to goods manufactured in our factories but also to our suppliers, and suppliers of their suppliers, all the way down the supply chain.

#### Responsibility

Responsibility for ASMPT UK's anti-slavery initiatives is as follows:

Training: ASMPT UK has trained managers involved in the recruitment of temporary workers and the Logistics and Materials Management team involved in the Supply Chain.

### Relevant policies

ASMPT UK operates the following policies that describe its approach to the identification of modern slavery risks and steps to be taken to prevent slavery and human trafficking in its operations:

- 1. Whistleblowing policy ASMPT UK encourages all its workers, customers, and other business partners to report any concerns related to the direct activities, or the supply chains of ASMPT UK. This includes any circumstances that may give rise to an enhanced risk of slavery or human trafficking. ASMPT UK's whistleblowing procedure is designed to make it easy for workers to make disclosures, without fear of retaliation. Employees, customers, or others who have concerns can use our confidential helpline/complete our confidential disclosure form.
- Employee code of conduct ASMPT UK's code makes clear to employees the actions and behaviour expected of them when representing ASMPT UK. ASMPT UK strives to maintain the highest standards of employee conduct and ethical behaviour when operating abroad and managing its supply chain.
- 3. ASMPT UK is committed to ensuring that its suppliers adhere to the highest standards of ethics. Suppliers are required to demonstrate that they provide safe working conditions where necessary, treat workers with dignity and respect, and act ethically and within the law in their use of labour. ASMPT UK works with suppliers to ensure that they meet the standards of the code and improve their worker's working conditions. However, serious violations of ASMPT UK's supplier code of conduct will lead to the termination of the business relationship.
- 4. ASMPT UK uses only specified, reputable employment agencies to source labour and always verifies the practices of any new agency it is using before accepting workers from that agency. Full identity checks and searches are performed prior to a temporary worker's employment through an agency, periodic checks are performed on the agency to ensure that processes are being followed.



### Due diligence

ASMPT UK undertakes due diligence when considering taking on new suppliers and regularly reviews its existing suppliers. ASMPT UK's due diligence and reviews include:

- Supplier contracts & adherence to regulations.
- Where possible suppliers holding BSI standards.
- Business and Process audit.
- D&B credit checks.
- Compliance checks new vendor (database) to check Geographical locations relating to conflict minerals or blacklisted countries.
- Invoking sanctions against suppliers that fail to improve their performance in line with an action plan or seriously violate our supplier code of conduct, including the termination of the business relationship,

### **Performance indicators**

ASMPT UK has reviewed its key performance indicators (KPIs). As a result, ASMPT UK:

- Requires all HR professionals, SCM Make Team Leaders and those working in Logistics and Materials Management to have completed training on modern slavery
- Has a developed a robust system for supply chain verification whereby ASMPT UK evaluates potential suppliers before they enter the supply chain; and
- Continually reviews its existing supply chains.

#### **Training**

ASMPT UK requires all HR professionals, SCM Make Team Leaders and those working in Production, Logistics and Materials Management to actively take part in annual refresher training sessions that are being run in during 2025.

ASMPT UK's modern slavery training covers:

- Our business's purchasing practices, which influence supply chain conditions, and which should therefore be designed to prevent purchases at unrealistically low prices, the use of labour engaged on unrealistically low wages or wages below a country's national minimum wage, or the provision of products by an unrealistic deadline.
- How to assess the risk of slavery and human trafficking in relation to various aspects of the business, including resources and support available.
- How to identify the signs of slavery and human trafficking.
- What initial steps should be taken if slavery or human trafficking is suspected.
- How to escalate potential slavery or human trafficking issues to the relevant parties within ASMPT UK.
- What external help is available, for example through the Modern Slavery Helpline, Gangmasters and Labour Abuse Authority and "Stronger together" initiative.
- What messages, business incentives or guidance can be given to suppliers and other business partners and contractors to implement anti-slavery policies; and



 What steps ASMPT UK should take if suppliers or contractors do not implement antislavery policies in high-risk scenarios, including their removal from ASMPT UK's supply chains.

# Awareness-raising programme

As well as training employees, ASMPT UK has raised awareness of modern slavery issues by placing digi-posters across ASMPT UK's premises.

The digi-posters explain to employees:

- The basic principles of the Modern Slavery Act 2015.
- How employers can identify and prevent slavery and human trafficking.
- What employees can do to flag up potential slavery or human trafficking issues to the relevant parties within ASMPT UK; and
- What external help is available, for example through the Modern Slavery Helpline.
